- b) Minimum required quantity is 100 Kgs.


Role and responsibilities of Rama Paper Mills Ltd.

This agreement comes into force from **7th January 2021 and will be valid for 5 years.**


Either party may terminate this agreement by giving thirty (30) days written notice to the other party.

The Principal agreed to award contract for job work as per the following terms & conditions:



This agreement is made under the "E-waste (Management & Handling) Rules 2016 which is called here said "Act"

 - Filing of periodical returns with State Pollution Control Board for E-waste
2. That the Contractor will not lift the items which are covered under schedule _ II of E-waste (Management & Handling) Rules 2016.
 3. That the Contractor shall alone be liable for fulfilling and maintaining all the required documents & records which are required under the said "ACT". The principal must provide copy of Form-2 to the contractor to be filled under guidance of the contractor.
 4. Taxes & Duties All are inclusive in quotation.
 5. That the Contractor shall maintain all the registers and records (Form-2 and Form-6) required to be maintained as per E-waste (Management & Handling) Rules 2016.
 6. The Contractor undertakes to hold full responsibility and liability for non-compliance of any applicable law in any manner on the part of the Principal. The Principal shall not be liable for any unlawful action or inaction on the part of the Principal. The Contractor however, shall indemnify the Principal for any loss or damages or claim it may suffer or incur due to unlawful action or inaction on the part of the Contractor.
 7. After lifting the e-waste from the principal premises, the principal is not liable and/or responsible for any loss which occurs due to damage, leakage, spillage, accident, pilferage etc.
 8. The Contractor shall have right to nominate its representative to be present at the time of fulfil the Compliance under the said ACT.
 9. That in case of any dispute and/or touching upon and/or related to this contract and/or anything incidental thereto including any claims of either of the parties shall be referred to the sole arbitration of Company's official not below the rank of General Manager whose award shall be final and binding upon the parties. The arbitration shall be in accordance with Indian Arbitration Act. The venue of arbitration shall be at the discretion of the arbitrator.
 10. That this agreement shall be valid for the **period from 1st June 2022 to 31st May 2025**
 11. That the Principal/Contractor is liable to make payments to each other as per annexure "A". The Annexure "A" will be a part of this agreement.
 12. That the Principal can request the contractor for a life time **"Registration Membership"**
 13. Both the parties have read and understand the contents of the above agreement and have executed this agreement on the day, month and year stated above.


